This Declaration of Trust is executed at Guwahati on this the 19<sup>th</sup> day of Oct, 2010

1. Mr Nawaz Uddin Choudhury s/o Late Samser Ali Choudhury aged about 66 years, resident of Vill & P.O.- Uttarkrishnapur, P.S.- Silchar, Dist.- Cachar, Assam.

And

2. Mr Shamsuddin Laskar s/o Late Amjad Ali Laskar aged about 72 years, resident of Ratanpur Road, P.S.&P.O.-Hailakandi, District- Hailakandi, Assam

Hereafter Jointly referred to as the Settlers or the Founders, of the FIRST PART

AND

3. Mr Nakib-uz Zaman Choudhury son of Haji Nawaz Uddin Choudhury aged about 36 years resident of Vill & P.O.- Uttarkrishnapur, P.S.- Silchar, Dist.- Cachar, Assam.

4. Mr Mahmudul Hassan Laskar son of Haji Shamsuddin Laskar aged about 34 years resident of Ratanpur Road, P.S.& P.O.- Hailakandi, District- Hailakandi, Assam

Hereafter referred to as the Trustees or Founder Trustees or as the Directors, of the OTHER PART.

Reference to the parties hereto, singly or jointly, shall mean and include, unless the context otherwise requires, their respective heirs, administrators, executors, representatives, assignees and successors-in-interest.

- The Founders were desirous of creating a trust for public charitable purposes and in fulfillment of such desire the Founders have settled a sum of Rs.25,000/- (Rupees Twenty Five Thousands only) on equal sharing basis by both the Settlers in cash to be held by the Trustees /Directors in public trust on the 1<sup>st</sup> day of July 2010, according to the terms of this document, by delivering the said amount to the Directors heretofore. And thus the trust shall be deemed to have commenced on and from 1<sup>st</sup> day of July 2010 and all the terms of this instrument shall be applicable from the that date.
- The Trustees /Directors shall hold and possess the settlement in trust according to the guidelines, objectives, terms and conditions of this document.

**WITNESSETH**

**Name**

1. The trust shall be called ENR WELFARE FOUNDATION (hereinafter referred to as 'the trust') having Head office of the Trust shall be situated at, VIP Road, Sonid, Garwahati, Assam, India, or at such other place or places as the Board of Trustees may decide from time to time. Branch / administrative offices can be opened in any part of the country for the smooth functioning of the Trust.

**Trust and Trust Property**

2. The Trustees /Directors shall hold the settled property, being the original corpus, in trust for public purposes according to the terms of this deed. As such, they shall be the first Trustees or Directors of this trust.
3. The trust and its funds shall ensure for the benefit of the public only and not for any private benefit of the Founders, Trustees or their relatives.
4. The Trustees /Directors shall stand and be possessed of the settled property, being the original corpus and all additions thereto by way of income, gifts or otherwise (the total of which shall herein referred to as the 'trust funds') in trust for public charitable purposes subject to the terms, conditions and provisions of this document.
5. This settlement is absolute subject only to the provisions of this deed.
6. The trust shall be irrevocable and no part of the trust funds shall in any case be applied for benefit of the Founders. If, in any case, the trust fails, or is held invalid there shall be no resulting trust in favour of the Founders but the trust funds shall be used or spent toward public charity according to the terms hereof.

**7. Aims & Objectives-**

The trust shall pursue the following objects subject to the condition that the same shall only be for public benefit

- 7.1. To promote National Integration, Communal Harmony, Universal Brotherhood and Global Peace.
- 7.2. To promote and advocate Human Rights and Fundamental Freedom for all without any discrimination of race, religion, caste, color, sex and language.
- 7.3. To establish residential and non-residential Educational Institution/School and Training centers for Education and skill development.
- 7.4. To run/ operate different types of Education program/Schools, Colleges, Centres of learning like formal, non-formal, pre-school for the education development of all sections of society with special care for the upliftment of the under privileged children and children from minority community.
- 7.5. To arrange / establish and maintain centers of quality Education, vocational education technical training, low cost education, formal & non-formal education.
- 7.6. To aid or establish any institution technical or otherwise, to promote Education of Arts, Science or other related fields for the benefit of downtrodden and weaker sections of the society.
- 7.7. To undertake, organize, conduct and facilitate, Courses, conference, lecture, research and Education on various aspects and of science, technology, trust and other fields.
- 7.8. To conduct research studies on the social and economic conditions of people with a view to involving ways and means for their development with in their social historical frame works and to seek promotion of rural development such as provision of drinking water rural industrialization as well as Public Convenience for people.

- 7.9. To organize and take up Health, Educational and Welfare programmes for needy among the economically weaker section and of various Minority Community on priority basis.
  - 7.10. To train the downtrodden people in general for human resource development in view of the emerging needs such as database development, resource survey methodologies, computer, environmental, studies, Health, Education, and energy problems.
  - 7.11. To undertake and promote the publication & translation of journal, research papers and books and to develop the audiovisual programme to disseminate knowledge pertaining to the objectives of the trust.
  - 7.12. To work with special concentration for the (Child & Women Welfare.) upliftment of the economically weaker section of the society and welfare of various Minority Community.
  - 7.13. To construct, maintain, alter, improve or develop any building belonging to the trust or works necessary or convenient for purpose of the trust.
  - 7.14. To issue appeals raise funds and accept gifts, donation subscriptions in cash or in kind and any property either movable or immovable for the achievement of the objective of the trust.
  - 7.15. To acquire, purchase or otherwise own or under take on loan or lease or hire temporality or permanently and movable or immovable property necessary or convenient for the furtherance of the objects of the trust.
  - 7.16. To organize Financial assistance, Scholarships, various grants and take-up Health, Educational and Welfare programmes for needy & poor Children.
  - 7.17. To organized awareness camps, health camps, March, workshops, campaign and exhibition.
  - 7.18. To provide and facilitate legal assistance to underprivileged and poor section of trust to fight for their rights and justice.
  - 7.19. To establish / run / manage hospitals, health centres, mobile health clinics, research centre to provide health care, counseling and referral services for all kinds of illness and diseases.
  - 7.20. To establish, build or manage Hostels, Short Stay Homes, Guest House, Rehabilitation Centers, Shelters, Crèches, Child Care Centre or Children's Home, Counseling Centres and Help Line Centers for Women, Children, Old aged persons, Drug addicts and other needy persons
  - 7.21. To acquire, purchase, receive, manage, take on lease and hold land, building or any other property of any kind from any person or Govt./ semi Govt. agency with a view to construct, erect and maintain gardens, buildings or structures as shelter/ low cost Houses for the poor and economically weaker section.
  - 7.22. To work for the welfare of Agricultural workers, Farmers, Unorganized Labours, Industrial Labours and Migrated Labours.
  - 7.23. To celebrate annual day of the trust every year as cultural & social event.
8. To open branches of ENR WELFARE FOUNDATION at various places to de-centralise the activities of the trust as and when required that the Trustees / Directors may think fit.
- The trust may also, in any manner, undertake to carry on all kinds of advancement of any other object of general public utility and for one or more such public charitable purposes to the exclusion of other's as the Trustees / Directors may think fit.
- Without prejudice to the generality of the foregoing objects or purposes but subject as aforesaid it is declared that the Trustees / Directors shall apply the income of the trust funds and may at their discretion at any time and from time to time apply also the trust funds or any part or parts of the trust funds in or towards any one or more of the objects or purposes which, in their opinion are charitable in nature and for the benefit of the general public, and of one object to the exclusion of the other or others in such proportion and manner in discretion, think proper.
- 9. Every contribution by the Directors to any other trust, institution, fund, scheme or activity having as its object/s all or any of the aforesaid objects shall be treated and deemed to be furtherance and achievement of the objects of this trust.
  - 10. The Directors shall be at liberty to use the income of the trust or its corpus including original corpus towards its objects; and to incur any pay any amount by way of expenditure, costs, charges, taxes or otherwise which may, in their opinion be, necessary, out of the income of the trust or out of the trust and including the original corpus
  - 11. The management and control of the Trust shall be completely vested in the Directors for the time being who shall be entitled to administer and manage the same in their sole discretion without any restrictions whatsoever as if they were the absolute owners of the Trust properties.
  - 12. AND GENERALLY to do in all public, charitable purposes for public benefit without any discrimination of Caste, Creed, Color, Gender, Religion, Faith, Race or any Nationality. That in case any of the objects of the Trust are held to be non charitable within the meaning of section 2 (1E) of the Indian Trust Act, or any statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.

Board of Trustees

- 13. The trust shall be managed by the Directors, collectively called the Board of Trustees/Directors, or Board.
- 14. The Board of Trustees shall have the power to increase the number of Trustees to any number upto maximum 11 Trustees with inclusion of nominated/elected Trust members/Member Trustees
- 15. The Board of Trustees will decide about the terms and rules governing the inclusion of nominated/elected Trustees.
- 16. The Board shall frame Rules for the manner in which elections shall be conducted and the Rules so framed for the first time shall be amended only by the Founder Trustees.
- 17. The Board of Trustees /Directors shall, from amongst them, appoint such office bearers as may be required and allot them such powers as thought fit by the Board

Powers of the Trustees/Directors

- 18. The Trustees /Directors shall have the power to invest the Trust funds, the properties and assets in any manner, mode and avenue as they, in their absolute discretion, deem fit.
- 19. The Trustees /Directors shall be entitled at such time or times, as they think fit and in their absolute discretion, to sell and convert the trust funds or any portion thereof.
- 20. The Trustees /Directors shall have power in their discretion to invest and accumulate the trust funds in the name of the trust or in their individual or joint names on behalf of the trust, in any investments permitted under these presents, with power to the Trustees /Directors at their discretion to vary and transpose any investments for others of any nature hereby authorised.
- 21. The Trustees /Directors shall stand possessed of such accumulations upon the same trust as are hereby declared or and concerning the trust funds provided always that the Trustees /Directors shall be at liberty to apply the whole or any part or parts of such accumulations at any time in or towards the trusts of such accumulations at any time in or towards the trusts here in contained as if the same had been the income arising in the year in which the same shall be so applied.
- 22. The Trustees /Directors shall have power in their discretion to accept, upon such terms as they may think fit, any donations or contributions of property of any kind from any person, company, firm, association, organizations, government, non government or semi government agencies, national or foreign funding agencies, family Trust, or corporate bodies may be desirous of making to the trust

Provided that the terms upon which such donations or contributions shall be accepted shall not in any way be inconsistent with or repugnant to the objects of these presents to be utilized only in furtherance of its objects

Provided further the Trustees /Directors shall, in their absolute discretion, be entitled to treat such donations or contributions or any part thereof as part of the corpus of the trust funds or to utilise such donations or contribution or any part thereof for the furtherance or fulfillment of the objects of the Trust.

- 23. The Trustees /Directors shall be entitled their discretion to borrow moneys or raise loans with or without security upon such terms, conditions and securities as they, in their discretion, deem fit and proper from time to time and manage the trust property comprised in these presents as security for repayment of the loans borrowed for the purpose of the trust. The Trustees shall not be personally liable for such guarantees or the securities.
- 24. Bank Account : The Trustees /Directors shall be entitled to open any type of Bank Account (s) weather Savings account, Current account, fixed or otherwise, in the name of the Trust or Institution (s) or Unit (s) run by the Trust with any scheduled banks (s) or post office (s) and to operate by Trustees /Directors jointly or through any Authorized signatory or signatories as Board of Trustees/Directors shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such Bank Account(s) shall be opened and operated jointly with signatures of two Trustees/Directors. The financial year for the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March and the accounts of Trust or Institution (s) or Unit (s) run by the Trust shall be audited yearly by the auditors (s) or chartered accountant or a firm of chartered accountants to be appointed by the Board of Trustees and the fee for auditor(s), if paid, shall be a part of outgoing amounts from the Trust Funds.

25. The Trustees /Directors shall have the power to administer, manage, control and deal with immovable properties belonging to the trust in any manner they deem fit and to sell, lease, mortgage, exchange, deal with and acquire immovable properties upon such term and conditions as they may, in their discretion, deem fit from time to time.
26. The Trustees /Directors shall have full power to apportion the trust funds and to compromise and compound all actions, suits and other proceedings and difference and demands and refer any such difference or demands to arbitration and to adjust, settle and approve all accounts relating to the trust funds and to execute the releases and all documents necessary in the premises and to do all other things relating the ratio respectively as fully as if they were absolutely entitled to the trust funds and without being answerable for the loss occasioned thereby.
27. Instead of themselves spending any sum for any purpose authorised by these presence by law or by statute the Trustees /Directors shall have full power to pay any sum for the purpose of such expenditure to any official or employee of the trust without being bound to look after the application thereof and the receipt of such official shall be complete discharge to the Directors for such payment and for seeing for the application thereof and to receive the honorarium or salary against his/her services or involvement in any of the project or programme run by the Trust, which must be decided by the Board of Trustees.
28. The Trustees /Directors shall be entitled to takeover the ownership and /or management of any trust, charity or other body on such terms and conditions as may be thought fit by them provided that such trust or charities do not have any objects or purposes in contradiction so those of this trust.
29. The Trustees /Directors shall have power to frame such rules and regulations as they think fit with respect to the working of the trust for fulfillment of the purpose of the trust and for carrying out the objectives of the trust. The Directors shall have power to grant Special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
30. The Trustees /Directors shall cause to be kept proper accounts of all transactions of the trust and shall get the same audited annually.

#### OTHERS

31. The Trustees /Directors shall not be responsible for, and shall be indemnified for any damage cause to them, as result of their acts or deeds performed as Directors out of good faith and *bona fide*.
32. If the Board of Trustees decides to dissolve the trust, the Trustees /Directors shall apply the trust funds in its entirety to the objects of the trust or to transfer the entire trust fund in favour of another institution, body or trust having objects similar to that of the trust which is also registered under section 12A of the Income Tax Act, 1961.
